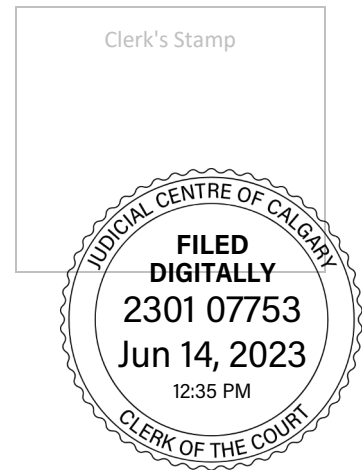

**UPON THE *EX PARTE* APPLICATION** of the Plaintiff/Applicant, Styro-Go Canada Inc. (**SGCI**), **AND UPON** reading the Affidavit of John Raymond Johnson sworn June 12, 2023, **AND UPON** hearing from counsel for SGCI *ex parte*; **AND UPON** the Court being satisfied, pursuant to Rule 6.4 of the Alberta *Rules of Court*, that no notice is necessary or that serving notice of the application on the Respondent might cause undue prejudice to the Applicant; **AND UPON** being satisfied that the Applicant would be irreparably harmed if this Order is not granted; **AND UPON** taking notice of the undertaking of the Applicant to abide by any Order in respect of costs or damages which may pertain to the granting and execution of this Order;

**IT IS HEREBY ORDERED THAT:**

1. The Application for an mandatory injunction is granted as follows. The Respondent, Robert Herritt (**Herritt**) is hereby ordered to immediately, and in any event within 24 hours of having received a copy of this Order, deliver up to the directors of SGCI, John Johnson and Roy Adam, the following:

- (a) Login credentials for the Styro-Go account on GoDaddy.com including the username and password in relation to the domain name “styrogo.com”;
- (b) Login credentials for the Styro-Go account on Hostgator.com including the Username and password for accessing the CPANEL portal associated with the web hosting platform, and the password for the username styrogoadmin;
- (c) PIN # used as verification code for the Styro-Go account on Hostgator.com;
- (d) Username and password to access all SGCI social media on the following platforms:
  - (i) Twitter (@styrogo);
  - (ii) Facebook;
  - (iii) Instagram (@styrogo);
  - (iv) Linked-In;
- (e) Login credentials including username and passwords to the email accounts [styrogo@gmail.com](mailto:styrogo@gmail.com) and [styrogointl@gmail.com](mailto:styrogointl@gmail.com);
- (f) Executed Consent letter to Rogers Communications Inc. providing consent to remove all access and authorization clearance for Robert Herritt with respect to the Styro-Go corporate Rogers account, in the form attached as Schedule “A”.

2. The application for an interim injunction is granted as follows. Mr. Herritt is hereby prohibited from:

- (a) accessing or using any email address ending with @styrogo.com for any purpose whatsoever (including deleting any emails), pending the final determination of this matter or further Order from this Court, including but not limited to:  
[customerservice@styrogo.com](mailto:customerservice@styrogo.com); [pickup@styrogo.com](mailto:pickup@styrogo.com); [sgadmin@styrogo.com](mailto:sgadmin@styrogo.com);  
[service@styrogo.com](mailto:service@styrogo.com); [robert.he@styrogo.com](mailto:robert.he@styrogo.com); [accounting@styrogo.com](mailto:accounting@styrogo.com)
- (b) accessing or using the SGCI social media accounts for any purpose whatsoever, pending the final determination of this matter or further Order from this Court.

3. The Applicant, Styro-Go Canada Inc., will preserve all business records, including but without limiting the generality of the foregoing, all records that are related to this Order and the emails and social media accounts of Styro-Go Canada Inc.

4. The Respondent may bring this matter back to the Commercial List for a review of this Order on 5 days' notice to the Applicant.
